A minimum grade of C (73.00% or 2.0) is required for nursing courses. All grades will be rounded to two decimal points. Failure in the clinical component of the course will require the student to repeat the entire course. In this event the student can receive no higher grade than a D for Nursing 330. Students must maintain a 2.5 GPA both in nursing and overall to advance in the nursing program.

Honor Code The Cedar Crest College Honor Code will be adhered to in this course. Please refer to your customs book for an explanation of the Cedar Crest College Honor Code. Violations during either the theoretical or clinical components of the course will result in failure of the course. Either plagiarism or careless scholarship, or both, may result in additional points being taken off the grade of a written assignment, so that the grade may be lowered down to and including a 0. This includes, but is not limited to, omitting quotation marks for quoted sentences or phrases, even if the rest of the documentation is present.

- Class Rules 1. This course adheres to all aspects of the Cedar Crest College student handbook and the Cedar Crest college Nursing student Handbook.
 - 2. Absence from clinical or exams will be excused if the instructor is informed PRIOR to the scheduled event. In the event of illness, hospitalization, or pregnancy, a statement from your attending physician certifying that you are physically and emotionally able to continue active participation in the nursing program, must be presented to the Nursing Department Chairperson in order to obtain clearance for clinical practice.
 - 3. Clinical make-up days, due to illness, will be scheduled by the clinical coordinator. Plans which require make-up days outside of previously scheduled clinical time or more than one make-up day per student will require an additional fee. Clinical remediation days will always require an additional fee.
 - 4. Unexcused absence or lateness during scheduled exams will result in missing all or a portion of the exam. Excused absences will result in a scheduled make-up exam. The instructor must be notified **prior** to the beginning of the examination should extenuating circumstances occur that prevent the student from taking the examination at the scheduled time. Make-up examinations will be scheduled in the Academic Advising Center in compliance with their rules and during normal hours of operation. No student is permitted to take any exam ahead of scheduled time. Final exams are to be taken as scheduled by the Registrar's office.
 - 5. Late assignments will result in the loss of five points for each day the assignment is late, including non-class days, a late clinical folder will reflect a 5 point per day deduction from the grade of each gradable item for each day it is late, missing non-gradable items from the clinical folder will result in a one point loss from the folder grade for each day they are late, a missed clinical evaluation meeting, without notice, results in a 20 point deduction from the clinical folder grade. Students must keep a hard copy of all written assignments required for this course. All written assignments should be saved for compiling in a portfolio

format at the end of the senior year. End of Chapter reviews must be dated after the class they apply to and prior to the next scheduled class.

- 6. Successful completion at Level Two Proficiency of the Pediatric ATI assessment is required in this course. If a student is not successful in the initial completion of the assessment then remediation to a minimum of 95% is required prior to the final exam. Please see the ATI guidelines for further directions.
- 7. Math Exams and Clinical Skills must receive a minimum of 80.00 %. Scores of less than 80.00% will result in clinical failure. Remediation is possible as per the following directions. If the Pediatric Medication Calculation Exam or the Fluid Calculation Exam scores are less than 80.00% the student must remediate with Academic Services or the course professor, and provide proof of the same, within 2 class sessions of the exam, in order to continue in clinical. If the Clinical Skill(s) scores are less than 80.00% the student must remediate in the clinical lab and successfully demonstrate the skill(s) either in clinical or to the lab coordinator as directed by the professor. If the Medication and Fluid Final Exam score is less than 80.00%, the student will not pass clinical.
- 8. The Clinical Information Packet, Clinical Skills Information Packet, Clinical Schedule, and Pacing Schedule posted in the clinical section of document sharing on the e-companion web-site are part of this syllabus, please see them for further information.
